3. I agree to remove any and all personal items from the boat prior to storage. I may elect to have the Marina perform this task for me for due consideration with applicable costs. Sutter's Marina is not responsible for items not picked up and will be subject to a item storage fee. _____
4. If my boat is equipped with a stern drive, I will supply an appropriate locking device, or contract to have one installed by the Marina. I will also provide the Marina with keys for the boats ignition, storage, or any trailer locking device, or I agree to pay \$20 per key to have the Marina proceed without them. Failure to provide any item needed to haul out by time of scheduled service, will result in losing position in schedule and will be rescheduled to next convenient time for Marina to schedule services needed. _____
5. The term of this lease begins the date the Marina takes possession of the boat and trailer (if applicable) up to and including June 1st. _____
6. I agree to pay any and all costs incurred by the Marina for delinquent account collections. All invoices are due within 5 days unless otherwise noted. _____
7. As owner of the boat and trailer 9if applicable), I agree to provide any liabilty and/or comprehensive insurance necessary and sufficient to protect my interests. It is acknowledged that the Marina does not insure the Lessee's property. _____

8. Sutter's Marina is not responsible for customer items not picked up.

9. If customer is picking up boat(s) and/or jetski(s), the customer has 5 days to pick up boat. After 5 days, Marina storage fees will be added to bill total.
